## This Month's Focus – Information Sharing

Confidentiality refers to guidelines within bowls about when information can be shared, with whom and rules around when it is not appropriate to share information. Every effort should be made to ensure that confidentiality is maintained for all concerned. However, there are circumstances when it is important that information is shared including to report or prevent harm to a child or an adult. The BDA Safeguarding policies for children and adults contain details of the confidentiality and disclosure requirements to support safeguarding of both groups. Information should be handled and disseminated on a need-to-know basis only. This includes the following people:

- Club and/or County Safeguarding Officer
- NGB Safeguarding Officer
- Parents/carers of the person who is alleged to have been abused (if the concerns relate to the parent or carer, seek advice from the NGB Safeguarding Officer, who will liaise with Children's Social Care services, about sharing information)
- Person making the allegation
- Children's Social Care / Adult Social Care / Police Information should be stored in a secure place with access limited to designated people, in line with data protection laws (e.g. that information is accurate, regularly updated, relevant and secure). Referrals through to the NGB Safeguarding Officer and/or the BDA Lead Safeguarding Officer will be stored using 'My Concern'.
